MINUTES OF THE INTERIM PARISH COUNCIL MEETING

Held on 01 June 2018 in

The Reading Room, The Mechanics Institute, Kirkby Malzeard at 7.15pm

The Meeting Commenced at 7.15pm

Present: Councillors Howard Mountain (Chairman), Geoff Lobley (Vice-Chairman), Ruth Broadley, Jane Aksut, Peter Saxon, Geoffrey Berry and Alan Brownlee, with Jen Hurford (Clerk), and 4 members of the public.

1. Welcome and apologies for absence.

The Chairman welcomed everyone to the meeting and noted apologies from County Cllr Margaret Atkinson and District Cllr Nigel Simms.

2. Declarations of Disclosable Pecuniary Interest.

Cllr Lobley declared a 'Close Association' for item 3a, and Cllr Brownlee for item 4a, and they took no part in the discussion or vote on these items.

3. Planning – consider response in respect of the following Planning Appeal deferred from last meeting so that further information could be considered:

a) 18/00025/NREFPP - Kendall Bank, Carlsmoor, Dallowgill – Siting of static caravan for office/light industrial use (use class B) – Fountain-Hewitt – original application 17/03053/FUL. Following discussion it was agreed to support the appeal based on the new documents submitted by the applicant which showed timber cladding to the caravan and landscape screening with trees, but object if no such cladding and screening were to be provided. It was also agreed to highlight the positive aspects of this rural business within the submission to the Planning Inspectorate. **Action: Chairman and Cllr Aksut to prepare response for submission.**

4. Planning – recent applications made to Harrogate Borough Council. The Parish Council will provide a response on the following case:

a) 18/01808/FUL – Turnways, Main Street, Kirkby Malzeard – Demolition of existing garage and outhouse; Erection of garage. – Tudbury - Council decided it had No Objections. **Action – Clerk to submit response to HBC.**

5. Any Other Business.

a) The Chairman reminded Cllrs that questions for the HBC Parish Consultation meeting had to be submitted by 8th June. It was agreed to query the frequency of recycling collection. **Action: Cllr Aksut to prepare question for Clerk to submit to HBC.**

b) Having taken responsibility for updating the Council's Facebook page, Cllr Brownlee suggested that it might be better organised as a Group to enable information to be more easily displayed. **Action: Cllr Brownlee to prepare a list of advantages to using a Facebook group for consideration at the next meeting.**

c) Cllr Aksut suggested that the posters requesting that the community take part in the NYPCC Rural Crime Survey be circulated which was agreed. **Action: Cllr Aksut to publicise Survey within the community.**
